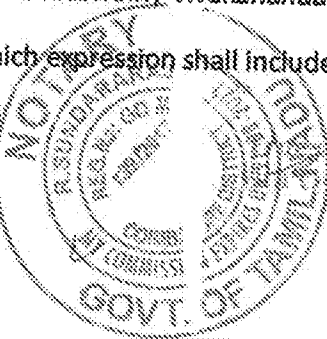

D. This Deed has been accordingly executed by the Parties to record the transfer of IPR effected by SKL in favour of SMPL and the terms subject to which the IP has been transferred


NOW THIS DEED RECORDING OF TRANSFER IPR WITNESSES AS FOLLOWS

1. SKL transferred all right, title, interest, use, property, possession, benefits, claims and demand at law and in equity of SKL in and to the IPR unto SMPL forever free from all encumbrances and from all claims and demands of SKL or any person claiming through or under SKL.

2. SKL hereby declares and covenants as follows:

a. SKL has full title and absolute power to transfer IPR already transferred and conveyed and no person or persons has or have any manner of right, title, interest or claim whatsoever in the IPR. If inspite of the declaration made as above and the covenants as to title , SMPL is made to suffer any loss of title to IPR or consequent loss of possession on account of any infirmity in the title of SKL, SKL shall indemnify and save harmless SMPL defending the title and possession of SKL and doing all acts, deeds and things as may be reasonably required in that respect and also pay SMPL any claim or loss that may be suffered or incurred by the SMPL by reason of any defect or loss of title to IPR .

b. SKL assure SMPL that SKL have not at any time done or knowingly suffered any act, Demand for the return of the IPR to SKL to the IPR already transferred to SMPL could be in

any way affected, and that SKL has not created any mortgage, charge, lien or encumbrance whatsoever on the IPR, that the IPR is not subject to any Lispendens and SKL does hereby agree and covenant with SMPL that SKL shall indemnify and keep indemnified at all times and from time to time SMPL in respect of any claim or claims by any person or persons to the IPR transferred to SMPL.

c. SMPL has become absolutely entitled to the IPR and accordingly, SMPL is entitled to deal with the IPR in its absolute discretion without any interruption or disturbance by SKL or any person claiming thorough or under the SKL and without any lawful disturbance or interruption by any other person whomsoever.

d. SKL shall at the cost of the organization so requiring execute and do every such assurance or thing necessary for further or more perfectly assuring title to IPR to SMPL, their successors and assigns or any other entity acquiring title to the IPR through SMPL without any additional consideration.

e. All the IPR including their working prototypes, together with necessary documents relating to the title of the IPR and documents pertaining to the registration of the IPR under respective patent offices has already been handed over to SMPL on the 9<sup>th</sup> day of February 2017 the receipt of which has already been acknowledged by SMPL.

f. SKL shall ensure compliance under the applicable statutes for effecting the transfer of Patents and Trade Marks already registered in their name to the name of SMPL or their successors and execute such deeds, documents and writings as may be necessary for effecting the transfer to the name of SMPL.

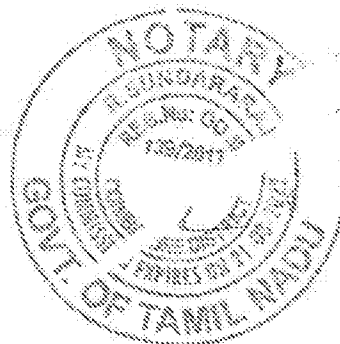

Radio opaque fibers, filaments, and textiles			
Abstract			
<p>A radio opaque fiber, filament, and yarn is disclosed herein. The radio opaque fiber, filament, or yarn comprises a matrix (102) comprising a plurality of radio opaque material (104) and a first polymer (106), where the radio opaque material (104) is at least one of a radio opaque element, an alloy of the radio opaque element, and a compound of the radio opaque element, or a combination thereof, wherein the radio opaque element is of an atomic number greater than or equal to 29, and wherein the matrix (102) forms a unified flexible structure. The radio opaque fiber, filament, or yarn further comprises a carrier polymer (108) which binds the plurality of the matrix (102) and imparts spinnability to form the fiber, filament, and yarn.</p>

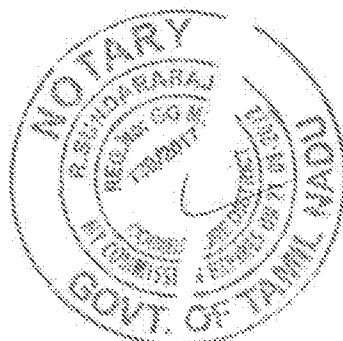
