PATENT SECURITY AGREEMENT

This Patent Security Agreement, effective as of March 7, 2019 ("the Effective Date"), is made by Siggpay Inc., a corporation having an address at 340 Ferndale Avenue, Stratford, Connecticut 06614 ("Siggpay") in favor of Forge IP, PLLC, a limited liability company having an address at 1077 Bridgeport Avenue, Suite 301, Shelton, Connecticut 06484 ("Forge IP").

WHEREAS:

A. Forge IP has performed various legal services for Siggpay relating to intellectual property matters and has laid out out-of-pocket expenses on behalf of Siggpay.

B. As of the Effective Date, Siggpay has a past due balance with Forge IP of **\$13,195.21**.

C. Siggpay has acknowledged this debt to Forge IP and has agreed that it will pay its past due balance to Forge IP as soon as it is financially able.

D. Siggpay has agreed to grant a security interest in certain property for the benefit of Forge IP, and has agreed as a condition thereof to execute this Patent Security Agreement for recording with the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Siggpay agree as follows:

1. Grant of Security. Siggpay hereby grants to Forge IP, for the benefit of Forge IP, a security interest in all of such Siggpay's right, title and interest in and to the following property:

(a) (i) U.S. Patent Application No. 16/059,435, entitled "Reward System For Micro Influencers In A Social Media Marketing Campaign," (ii) all inventions and improvements described and claimed therein, (iii) the right to sue or otherwise recover for any and all past, present and future infringements and other violations thereof, (iv) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including payments under all licenses entered into in connection therewith,

and damages and payments for past, present or future infringements thereof) and (v) all reissues, divisions, continuations, continuations-in-part, substitutes, renewals, foreign counterparts and extensions thereof, all improvements thereon and all other rights of any kind whatsoever accruing thereunder or pertaining thereto; and

(b) any and all Proceeds of the foregoing.

2. Recordation. Siggpay authorizes and requests that the United States Commissioner of Patents and Trademarks record this Patent Security Agreement.

3. Governing Law. This Patent Security Agreement shall be governed by, and construed and interpreted in accordance with, the law of the State of Connecticut.

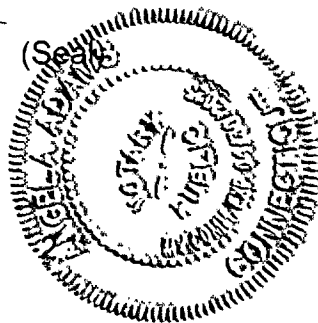
