or any applications or Letters Patent included within the Patent Rights and further promptly to execute and deliver to Assignee any and all additional papers, instruments or affidavits that may be requested by Assignee to apply for, obtain, maintain, issue and enforce such Inventions and Patent Rights and any equivalents thereof which may be necessary or desirable to carry out the purposes thereof or otherwise to implement the terms of this ASSIGNMENT.

Assignor hereby authorizes and empowers Assignee to invoke and claim for any applications or Letters Patent included within the Patent Rights the benefit of any rights to which Assignor might be entitled under international law or under the laws of any particular country (such as, without limitation, the right of priority provided by the International Convention for the Protection of Industrial Property, as amended) and to invoke and claim such rights without further written or oral authorization from Assignor.


