
ASSIGNMENT



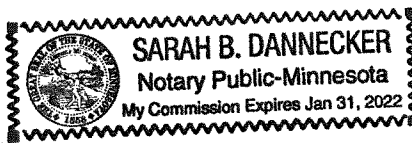
