GLOBAL IP ASSIGNMENT DEED dated _ 27 _ December 2018

PARTIES

- (1) The companies listed in Schedule 1 (each an **Assignor** and together the **Assignors**); and
 - (2) the companies listed in Schedule 2 (each an **Assignee** and together the **Assignees**)
- (each a **party** and together, the **parties**)

Words and expressions used in this Deed shall be interpreted in accordance with Schedule 7 (Definitions and Interpretation).

WHEREAS:

- (A) This Deed is entered into pursuant to a sale and purchase agreement dated 29 September 2018 between Mars, Incorporated (the **Seller**) and Luigi Lavazza S.p.A. (the **Purchaser**), as amended from time to time (the **SPA**), pursuant to which the Seller and certain of its Affiliates (including the Assignors) are in the process of transferring to the Purchaser other assets and the Purchaser will be, as of the Closing Date, the successor in interest to the Drinks Business of the Seller and its Affiliates (including the Assignors), and such business is ongoing and existing.
- (B) Each Assignor has agreed to assign its right, title and interest in and to its Transferring Owned IP to the Designated Assignees.

IT IS AGREED:

1. Assignment

Pursuant to the SPA, the Assignor of each Transferring Owned IP hereby assigns to the Designated Assignee for that Transferring Owned IP, subject to the terms and conditions of any licences granted to third parties as of the date hereof, all its right, title and interest in and to the relevant Transferring Owned IP, including:

- (a) all statutory and common law rights, title and interest attaching to that Transferring Owned IP, together with the goodwill of the business relating to the goods and services in respect of which that Transferring Owned IP is registered or used;
- (b) the right to sue, bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (including to obtain injunctive relief and collect and retain damages recovered and any other payments, including royalties, resulting from such proceedings, claims or actions) in respect of any infringement, unauthorised use, dilution or any other cause of action arising from that Transferring Owned IP that may occur or have occurred before, on or after the date of this Deed;
- (c) the right to receive any and all income, royalties and payments due and/or payable, relating to the period after the date hereof (or, pursuant

to clause (b) above, prior to the date hereof) with respect to the Transferring Owned IP;

- (d) the right to prosecute, maintain and defend the Transferring Owned IP; and
- (e) the right to claim priority based on the filing date of any Transferring Owned IP.

2. No representations or warranties

Except as set out in the SPA, nothing in this Deed shall be construed as a warranty or representation by any Assignor in respect of any of the Transferring Owned IP.

3. Miscellaneous

3.1 Costs

Except as otherwise provided in this Deed, each party shall pay its own Costs incurred in connection with negotiating, preparing and executing this Deed.

3.2 Further Assurances

- (a) Subject to clause 3.2(b) of this Deed, the Assignees shall be responsible for all steps required to record the effect of, and otherwise implement, this Deed, including:
 - (i) determining what steps are required to achieve that recordal, and whether it wishes to take those steps;
 - (ii) preparing any necessary additional documentation (including any local transfer agreements in respect of Transferring Owned IP that may be required); and
 - (iii) payment of any Intellectual Property Rights registry and other Costs associated with that recordal and implementation.
- (b) In respect of each Transferring Owned IP, for an initial period of 12 months from the date of this Deed, and (provided that the relevant Assignee has, within such initial 12-month period, provided to the relevant Assignor for execution such local assignment agreements for the relevant jurisdiction which that Assignee reasonably believes to be sufficient in order to record the effect of this Deed in such jurisdiction) thereafter for an additional 48-month period:
 - (i) each Assignor shall execute such local assignment agreements for that Transferring Owned IP as provided to that Assignor by the relevant Assignee for the relevant jurisdiction and, to the extent that any Assignee reasonably requires any other assistance of an Assignor to record the effect of this Deed, each Assignor shall promptly execute and deliver all further documents and perform all such acts that may reasonably be required (which, for the avoidance of doubt, shall be prepared

by that Assignee who shall bear the Costs associated with that preparation) for the purpose of vesting in the relevant Assignee the full benefit of the right, title and interest assigned to that Assignee under this Deed; and

- (ii) to the extent that the relevant Transferring Owned IP is an Internet domain name, each Assignor agrees to assist the relevant Designated Assignee in changing the technical and administrative contact information for that Internet domain name with the applicable Internet domain name registrar to such information of such Designated Assignee's choice (including by delivering to the Designated Assignee any and all applicable user names and passwords for related accounts to enable the Designated Assignee to assume control of such Internet domain name).
- (c) Without prejudice to clause 3.2(b), each Assignor shall, at the relevant Designated Assignee's cost and direction, pending formal registration or recordal of the assignment of the Trade Marks that are filed or registered in the jurisdiction of China and form part of the Transferring Owned IP to such Designated Assignee:
 - (i) if legally required to do so, pay all application, filing, registration, renewal and other fees as they fall due;
 - (ii) if legally required to do so, promptly satisfy all official actions issued by any relevant trade mark registry or authority;
 - (iii) provide the Designated Assignee with all information and other assistance reasonably required to enable the Designated Assignee to prepare, file or prosecute applications for registration of any of the Transferring Owned IP (including producing, in the appropriate form, any evidence of its use);
 - (iv) ensure that copies of all correspondence that it or its agents receive (including any renewal advice or other notification received from any relevant registry) are promptly delivered to the Designated Assignee;
 - (v) provide the Designated Assignee with all information and other assistance reasonably required by the Designated Assignee to conduct, defend or settle any relevant claims actions or proceedings (including if requested by the Assignee, bringing proceedings in its own name or lending its name to any proceedings brought by the Designated Assignee); and
 - (vi) not, and shall instruct and ensure that its agents shall not, allow any Transferring Owned IP to lapse unless the Designated Assignee consents in writing.

3.3 Legal Relationship

Nothing in this Deed shall constitute a partnership between the parties nor make any party the agent of any other party for any purpose.

3.4 Conflict with Other Agreements

If there is any conflict between the terms of this Deed and any other agreement, the terms of this Deed shall prevail.

3.5 Whole Agreement

- (a) This Deed and the SPA together set out the whole agreement between the parties in respect of the subject matter of this Deed and supersedes any previous draft, agreement, arrangement or understanding, whether in writing or not, relating to its subject matter. It is agreed that:
 - (i) no party has relied on or shall have any claim or remedy arising under or in connection with any statement, representation, warranty or undertaking made by or on behalf of the other party (or any of its Connected Persons) in relation to the subject matter of this Deed that is not expressly set out in this Deed or the SPA;
 - (ii) any terms or conditions implied by Law in any jurisdiction in relation to the subject matter of this Deed are excluded to the fullest extent permitted by Law or, if incapable of exclusion, any rights or remedies in relation to them are irrevocably waived;
 - (iii) the only right or remedy of a party in relation to any provision of this Deed shall be for breach of this Deed or the SPA; and
 - (iv) except for any liability in respect of a breach of this Deed or the SPA, no party (nor any of its Connected Persons) shall owe any duty of care or have any liability in tort or otherwise to any other party (or its respective Connected Persons) in relation to the subject matter of this Deed.
- (b) Nothing in this clause 3.5 shall limit any liability for fraud or fraudulent misrepresentation.
- (c) Each party agrees to the terms of this clause 3.5 on its own behalf and as agent for each of its Connected Persons.

3.6 Waivers

Except as expressly provided in this Deed, no failure or delay by any party in exercising any right or remedy relating to this Deed or the SPA shall affect or operate as a waiver or variation of that right or remedy or preclude its exercise at any subsequent time. No single or partial exercise of any such right or remedy shall preclude any further exercise of it or the exercise of any other remedy. A party may only waive its rights, powers, remedies and obligations

under this Deed by notice in writing of such waiver, which may be given subject to such conditions as the grantor may in its absolute discretion decide.

3.7 Counterparts

This Deed may be executed in any number of counterparts, and by each party on separate counterparts. Each counterpart is an original, but all counterparts shall together constitute one and the same instrument. Delivery of a counterpart of this Deed by e-mail attachment or telecopy shall be an effective mode of delivery.

3.8 Variations

No amendment of this Deed shall be valid unless it is in writing and duly executed by or on behalf of all of the parties to it.

3.9 Invalid Terms

Each of the provisions of this Deed and the SPA is severable. If any such provision is held to be or becomes invalid or unenforceable in any respect under the Law of any jurisdiction, it shall have no effect in that respect and the parties shall use all reasonable efforts to replace it in that respect with a valid and enforceable substitute provision the effect of which is as close to its intended effect as possible.

3.10 No Third Party Enforcement

A person who is not a party to this Deed shall have no right under any statutory provision to enforce any of its terms.

4. Governing Law and Arbitration

4.1 This Deed and any non-contractual obligations arising out of, or in connection with, it shall be governed by, and interpreted in accordance with, English law.

4.2 All disputes (including claims for set-off and counterclaims) arising out of or in connection with this Deed, including disputes arising out of or in connection with: (a) the creation, validity, effect, interpretation, performance or non-performance of, or the legal relationships established by, this Deed; and (b) any non-contractual obligations arising out of or in connection with this Deed, shall be referred to and finally resolved by arbitration, under the 2014 LCIA Rules of Arbitration (the **LCIA Rules**) of the London Court of International Arbitration (the **LCIA**). The LCIA Rules are deemed to be incorporated by reference into this Deed except (a) that any provisions in the LCIA Rules relating to the nationality of arbitrators and to the appointment of an emergency arbitrator shall be disappplied in their entirety and (b) as they may be modified in this Deed or by agreement of the parties to the arbitration.

4.3 The place and seat of arbitration shall be London, England. The number of arbitrators shall be three (3). The claimant(s) and the respondent(s) shall form two separate sides for the purposes of the formation of the arbitral tribunal and each side shall be entitled to nominate one arbitrator, with the third arbitrator, who shall serve as president of the tribunal, to be nominated by the party-nominated arbitrators. If the third arbitrator is not so nominated within 30 days

after the date of nomination of the later of the two party-nominated arbitrators, the third arbitrator shall be chosen by the LCIA. The language to be used in the arbitral proceedings shall be English.

- 4.4 Each party irrevocably and unconditionally consents to such arbitration as the sole and exclusive method of resolving any dispute arising out of or in connection with this Deed, including any question regarding its existence, validity or termination. The award of the arbitral tribunal shall be final and binding on the parties. The parties agree that they will not have recourse to any judicial proceedings, in any jurisdiction whatsoever, for the purpose of seeking appeal, annulment, setting aside, modification or challenge of the award, its terms or effect insofar as such exclusion can validly be made. The award may be enforced including by way of judgment upon the award in any court having jurisdiction thereof, or any application may be made to such court for a judicial acceptance of the award and an order of enforcement, as the case may be.
- 4.5 The parties agree for the purposes of Article 22.1(ix) of the LCIA Rules to the consolidation of any dispute, controversy or claim arising out of, relating to, or in connection with, this Agreement with any other dispute arising out of, relating to, or in connection with, any other Transaction Document (as defined in the SPA). Either party may apply to the arbitral tribunal constituted under this Agreement for an order that any dispute, controversy or claim arising out of, relating to or in connection with this Agreement is related to an already pending dispute (**Related Dispute**). The parties agree and acknowledge that a party to any other Transaction Document may apply to the related arbitral tribunal constituted under that Transaction Document for an order that the Related Dispute is related to any dispute, controversy or claim arising out of, relating to or in connection with this Agreement. Any application for an order under this clause 4.5 shall be made as soon as practicable with notice to all parties to any dispute, controversy or claim arising out of, relating to or in connection with this Agreement and all parties to the Related Dispute. The arbitral tribunal under this Agreement or under the other Transaction Document may if considered appropriate, with the approval of the LCIA Court, make an order that the disputes be consolidated. If two or more arbitral tribunals under this Agreement or any other Transaction Document issue a consolidation order, the order issued first shall prevail. If two or more arbitration proceedings are consolidated under such consolidation order, the arbitral tribunal having first issued the consolidation order shall proceed as the arbitral tribunal in the consolidated proceeding. The appointment of the other arbitral tribunal(s) shall terminate upon making of the consolidation order by the first arbitral tribunal and shall be deemed to be functus officio. The parties to the consolidated proceedings shall be deemed to have participated in the constitution of the arbitral tribunal in the consolidated proceedings and agree that they shall be bound by any award rendered by the arbitral tribunal in the consolidated proceedings.
- 4.6 By agreeing to arbitration, the parties do not intend to deprive any court of competent jurisdiction of its ability to issue any form of provisional remedy, including a preliminary injunction or attachment in aid of the arbitration, or

order any interim or conservatory measure. A request for such provisional remedy or interim or conservatory measure by a party to a court shall not be deemed a waiver of the agreement to arbitrate.

Definitions and Interpretation

- (a) in respect of each Transferring Owned IP listed in Schedule 3 (Designs), Schedule 4 (Patents), Schedule 5 (Trade marks) (and any goodwill related to those trade marks) or Schedule 6 (Domain names), the Assignee listed in the 'Designated Assignee' column of the relevant Schedule in relation to that Transferring Owned IP; and
- (b) in respect of any other Transferring Owned IP, Mars Drinks North America, LLC;

Dispute means a dispute arising between the parties out of or in connection with this Deed, including disputes arising out of or in connection with:

- (a) the creation, validity, effect, interpretation, performance or non-performance of, termination, or the legal relationships established by, this Deed;
- (b) claims for set-off and counterclaims; and
- (c) any non-contractual obligations arising out of or in connection with this Deed;

Drinks Business is defined in the SPA;

Drinks IP is defined in the SPA;

Excluded IP is defined in the SPA;

Governmental Authority means any administrative, executive, judicial, legislative, regulatory, licensing, competition or other governmental authority (including any Tax Authority) having applicable jurisdiction;

Intellectual Property Rights means all rights throughout the world in and to intellectual property, whether registered or unregistered, including rights in:

- (a) patents, utility models and rights in inventions;
- (b) know-how, confidential information and trade secrets;
- (c) trade marks, service marks, rights in logos, trade names, rights in each of get-up and trade dress, rights to sue for passing off (including trade mark-related goodwill), rights to sue for unfair competition, and domain names (together with the rights described in (i)-(iii) below, **Trade Marks**);
- (d) copyright, moral rights, database rights and rights in designs;
- (e) intellectual property rights in software, including in any proprietary configurations developed for use with third party applications;
- (f) any other intellectual property rights; and
- (g) all rights or forms of protection, subsisting now or in the future, having equivalent or similar effect to the rights referred to in paragraphs (a) to (f) above,

in each case, including: (i) all goodwill associated with the business symbolised by Trade Marks; (ii) all rights, subject to applicable laws, to sue and recover damages and obtain equitable relief for past, present and future infringement, misappropriation or other violation thereof and to collect and receive all damages, royalties and other proceeds and payments therefrom; and (iii) all divisionals, continuations, continuations-in-part, reissues, extensions, re-examinations and renewals, and references in this Deed to **registered Intellectual Property Rights** include Intellectual Property Rights for which an application for registration has been made;

Law means any statute, law, rule, regulation, guideline, ordinance, code or rule of law issued, administered or enforced by any Governmental Authority, and any judicial or administrative interpretation of any of these;

parent company means any company which holds a majority of the voting rights in another company, or which is a member of another company and has the right to appoint or remove a majority of its board of directors, or which is a member of another company and controls a majority of the voting rights in it under an agreement with other members, in each case whether directly or indirectly through one or more companies;

Seller Group means Mars, Incorporated and its subsidiaries from time to time but excluding the Assignees;

SPA is defined in Recital (A);

subsidiary and **subsidiaries** means any company in relation to which another company is its parent company;

Tax or **Taxation** means (a) taxes on income, profits and gains, and (b) all other taxes, levies, duties, imposts, charges and withholdings in the nature of taxation, including any excise, property, value added, sales, transfer, franchise and payroll taxes (including national insurance or social security

contributions), together with all penalties, charges, fees and interest relating to the foregoing or to any late or incorrect return in respect of any of them;

Tax Authority means any taxing or other authority (whether within or outside the United Kingdom) competent to impose any Tax liability, or assess or collect any Tax; and

Trade Mark is defined in the definition of Intellectual Property Rights; and

Transferring Owned IP means:

- (a) the registered or applied-for Intellectual Property Rights listed in Schedule 3 (Designs), Schedule 4 (Patents), Schedule 5 (Trade marks) and Schedule 6 (Domain names); and
- (b) any and all Drinks IP (other than the Intellectual Property Rights listed in subparagraph (a) above) owned by an Assignor.

2. **Interpretation.** In this Deed, unless the context requires otherwise:



after the date of this Deed and increases or alters the liability of a party under this Deed.

4. **Schedules.** The Schedules comprise schedules to this Deed and form part of this Deed.
