NOW, THEREFORE, in consideration of the \$1 purchase price paid from Assignee to Assignor and of other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor confirms that it has sold, assigned and transferred and by these presents does hereby sell, assign and transfer unto said Assignee, its successors, assigns and legal representatives, Assignor's entire right, title and interest in and throughout the United States of America, its territories and all foreign countries, in and to said Applications (and any inventions described therein) and such patents as may issue thereon, and any reissue, continuation, continuation-in-part, divisional and foreign counterparts thereof and including the right to claim priority under any applicable statute, treaty or convention based on any of said Applications or inventions thereof; said Applications and patents to be held and enjoyed by said Assignee for its own use and behalf and for its successors, assigns and legal representatives, to the full end of the term for which said patents may be granted as fully and entirely as the same would have been held by Assignor had this assignment not been made; Assignor hereby conveys all rights arising under or pursuant to any and all international agreements, treaties or laws relating to the protection of industrial property by filing any such Applications, all choses in action pertaining to the Applications or patents including the right to sue for and collect damages and other recoveries for past infringement thereof, all rights to initiate proceedings before government and administrative bodies, and all files, records and other materials arising from the prosecution, exploitation, or defense of rights and registrations pertaining to the Applications or patents. Assignor hereby acknowledges that this assignment, being of its entire right, title and interest in and to said Applications, carries with it the right in Assignee to apply for and obtain from competent authorities in all countries of the world any and all patents by attorneys and agents of Assignee's selection and the right to procure the grant of all such patents to Assignee for its own name as assignee of the entire right, title and interest therein;

AND, Assignor hereby further agrees to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the aforesaid Applications and patents to said Assignee, its successors, assigns and legal representatives, including the execution of applications for patents in foreign countries, and the execution of substitution, reissue, divisional, continuation or continuation-in-part applications and preliminary or other statements and the giving of testimony in any interference or other

proceeding in which said inventions or any application or patent directed thereto may be involved;


