ASSIGNMENT


2. 3. Binds his heirs, legal representatives, and assigns, as well as himself, to do, upon Assignee's request and at Assignee's expense, but without additional consideration to him, all acts reasonably serving to assure that the Patents shall be held and enjoyed by Assignee as fully and entirely as the same would have been held and enjoyed by Assignor, his heirs, legal representatives, and assigns if this Assignment had not been made; and particularly to execute and deliver to the Assignee all lawful documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by Assignee; to communicate to Assignee all facts known to Assignor relating to the Patents or the history thereof; to furnish Assignee with any and all documents, photographs, models, samples, and other physical exhibits in Assignor's control or in the control of his heirs, legal representatives, or assigns which may be useful or establishing the facts relating to the conception, disclosure, and reduction to practice of subject matter described in the Patents; and to testify to the same in any litigation or proceeding related thereto.

4. Conveys to Assignee, and to its successors and assigns, the right to bring suit for and to collect damages for any infringement of the Patents, for any use of provisional rights to which the Patents may be entitled, for any other cause of action arising from Assignor's ownership interest in the Patents, and for any violation by others of any federal or state tort or antitrust or unfair competition laws of any country, and the right in and to any and all reissues, reexaminations, *inter partes* reviews, and extensions of patents issuing in the future from the Patent. The rights granted under this Assignment include the right to all income, royalties, damages, or payments due or payable as of the effective date written below, including, without limitation, all claims for damages

by reason of past, present or future infringements or other unauthorized use of any of the Patents, Assignee to have and hold the interests herein assigned to the full ends of the term of the Patents, and of any and all reissues and/or extensions thereof.
