AND ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue said application to the said ASSIGNEE, his successors, legal representatives and assigns, in accordance with the terms of this instrument.



AND ASSIGNOR HEREBY further covenants and agrees that in light of the good and valuable consideration acknowledged above: (1) ASSIGNOR will not be compensated nor is entitled to any other consideration beyond that already provided by ASSIGNEE or as might hereafter be provided at ASSIGNEE's sole discretion and good will; and (2) ASSIGNOR waives his/her rights to any additional consideration and confirms that the above forms an agreement between ASSIGNOR and ASSIGNEE for the purpose of Section 134 of Israel's Patents Law.


