PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT, dated as of 14 JANUARY, 2016 (this "Assignment"), is entered into by and between Biomet Manufacturing, LLC, an Indiana limited liability company ("Assignor"), and Zimmer Biomet Holdings, Inc., a Delaware corporation ("Assignee").

RECITALS

WHEREAS, Assignor has agreed to sell, assign, transfer, convey and deliver to Assignee, and Assignee has agreed to purchase, acquire and accept from Assignor, all of Assignor's right, title and interest in and to the Assigned Patents (as defined below); and

WHEREAS, Assignor has agreed to execute this Assignment for recordation by Assignee with the United States Patent and Trademark Office ("USPTO").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

AGREEMENT

1. Assignment. Assignor hereby irrevocably and unconditionally assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the patents and patent applications set forth on Exhibit A, and in and to any and all divisions, continuations, continuations-in-part, reissues, reexaminations and extensions of said patents and patent applications (the "Assigned Patents") together with any and all claims, demands, and causes of action for infringement, of the Assigned Patents, past, present, and future, and all of the proceeds from the foregoing.
2. Recordation. Assignor hereby authorizes the Commissioner for Patents in the USPTO to record and register this Assignment upon request by Assignee.
3. Rights of Third Parties. Nothing expressed or implied in this Assignment is intended or shall be construed to confer upon or give any person, other than the parties hereto and their permitted successors and assigns, any legal or equitable right, benefits or remedy of any nature whatsoever under or by reason of this Assignment.
4. Governing Law. This Assignment shall be governed by and construed under the laws of the State of Delaware (without regard to the conflict of law principles thereof).
5. Counterparts. This Assignment may be executed in two (2) or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Any facsimile or electronic copies hereof or signature hereon shall, for all purposes, be deemed originals.
