1. Article 1 of the Articles of Incorporation of this corporation is amended to read as follows:

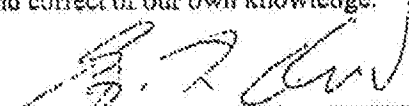
1. The name of this corporation is MARKWINS BEAUTY BRANDS, INC.
