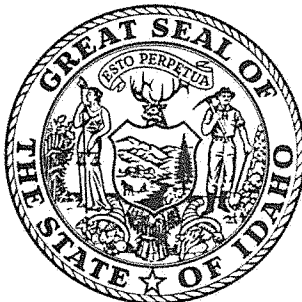

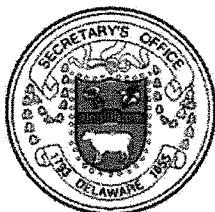

**FIRST:** The name and state of organization of each of the constituent limited liability companies that is a party to the Merger Agreement (as defined below) are:
