## PATENT ASSIGNMENT

This PATENT ASSIGNMENT (the "Assignment"), effective as of August 1, 2018 (the "Effective Date") is by and between GALTRONICS CORPORATION LTD, a Company duly organized and existing under the laws of Israel ("Assignor") and GALTRONICS USA, INC., a Company duly organized and existing under the laws of Arizona, USA, ("Assignee") (each a "Party") and collectively, the "Parties").

WHEREAS the parties entered into the IP Transfer Agreement, dated as of August 1, 2018, assigning various Assigned Patents and Patent Applications listed in Appendix A hereto (hereafter referred to as the "Assigned Patents and Patent Applications").

NOW, THEREFORE, for good and valuable consideration, and pursuant to the IP Transfer Agreement the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

Conveyance. Assignor does hereby sell, convey, assign and transfer to Assignee all of Assignor's right, title, and interest in and to (i) the Assigned Patents and Patent Applications, and all related continuations, continuations-in-part, divisionals, reissues, re-examinations, substitutions, and extensions thereof, and (ii) all benefits, privileges, causes of action, and remedies relating thereto throughout the world, including, without limitation, all of Assignor's rights to: (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement or other violations thereof, (c) grant licenses or other interests therein, and (d) any rights of priority in the Assigned Patents and Patent Applications, including any international applications filed under the Patent Cooperation Treaty.

Recordation Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the owner of the Assigned Patents and Patent Applications, and to issue the Assigned Patents and Patent Applications to Assignee, as assignee of Assignor's entire right, title and interest in, to, and under the same. Assignee shall have the right to record this Assignment with

all applicable governmental authorities and registrars so as to perfect its ownership of the Assigned Patents and Patent Applications.




