Gerlach, do sell, assign and transfer to ASSIGNEE, the right to claim priority to the Application for all applications pursuant to the Patent Cooperation Treaty and national and regional applications filed therefrom, all applications for the territory of the United States of America and all continuation, divisional, continuation-in-part and reissue applications thereof, and all patent applications in foreign countries and the right to be granted a patent for any of the foregoing applications.

The Commissioner of Patents is hereby authorized and requested to issue the Letters Patent solely in accordance with the terms of this Assignment, to ASSIGNEE, its successors, legal representatives and assigns, as an assignee of an equal, undivided right, title and interest therein.
