I covenant that I am the lawful owner of the said Application, inventions, and improvements, that the same are unencumbered, that no license has been granted to make use, or vend the said inventions or improvements or any of them, and that I have the full right to make this assignment.

This assignment shall be binding upon my heirs, executors, administrators, and/or assigns, and shall inure to the benefit of the heirs, executors, administrators, successors, and/or assigns, as the case may be, of said Assignee.
