applications in any jurisdictions on the Invention, including (but not limited to) the right to collect and receive any damages, royalties, or settlements for such infringements; any rights to sue for injunctive or other equitable relief; and any causes of action relating to any patents issuing from any the Patent Application or any other patent applications on the Inventions.

The Assignors authorize the Assignee (or its agent or attorney) to enter the jurisdiction, serial number, and filing date of the Patent Application in the spaces provided above (if not filled in when the Assignors sign this Assignment).

reasonably necessary) to the Assignee's, its successors', or its assigns' full enjoyment, protection, enforcement, and title in and to the Inventions and any rights hereby transferred.

The Assignee can assign any rights the Assignee takes under this Assignment without restriction.

The Assignors confirm the Assignors' absolute assignment to Assignee of any rights the Assignors may have in the Inventions and the Patent Application to the full extent that the Assignors would have had had this Assignment not been made.
