**WHEREAS**, Assignee, namely CHEMISTRY HOLDING, INC., is desirous of acquiring from Assignors the entire right, title, and interest in and to the ‘852 Application, the inventions disclosed in the ‘852 Application, and any patent that may eventually issue from the ‘852 Application, including any patent that may eventually issue from any subsequent applications claiming priority to the ‘852 Application, both in the United States and in foreign countries worldwide.

**NOW, THEREFORE**, for and in consideration of the premise and the mutual promises hereinafter set forth for and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby sell, assign and transfer unto said Assignee, its successors and assigns, the entire right, title and interest in and to the '852 Application, the inventions disclosed in the '852 Application, any patents that may issue from the '852 Application, including any patents that may issue from any subsequent applications claiming priority to the '852 Application, both in the United States and worldwide, and Assignors hereby authorize and request that the Commissioner of Patents and Trademarks issue any said patents that may issue from the '852 Application in the name of Assignee, or its successors and assigns; and Assignors hereby authorizes Assignee, or its successors and assigns, to file in its own name applications for patent in both the United States and foreign countries worldwide in connection with the inventions hereby transferred, under the International Convention claiming the priority to '852 Application or otherwise, and to secure in its own name the patents issued thereon; and Assignors hereby agrees that, upon request, Assignors will sign all papers, and make all rightful affirmations, and do all acts which said Assignee, its successors or assigns, may consider necessary in connection with the '852 Application, and in connection with any other United States or foreign applications that may be filed in connection with said inventions, and with any improvements thereon, and in connection with any patents issued or reissued thereon.


