
WHEREAS, ASSIGNOR believes himself to be the original inventor of the subject matter claimed in said patent application; and

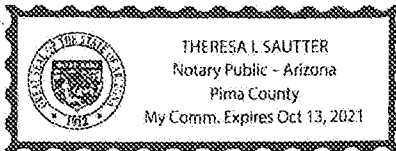


