ASSIGNMENT OF UNITED STATES PATENT RIGHTS

Now therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignors hereby sell, convey, assign, transfer and deliver to the Assignee, its successors and assigns, the entire right, title and interest in the Transferred Patent, and including without limitation any utility, continuation, divisional, and continuation-in-part application, reissue, re-examination, extensions or foreign equivalents thereof, and all rights of priority and corresponding rights that are or may be secured under the laws of the United States and any foreign country (all rights therein provided by international treaties or conventions), now or hereinafter in effect, together with the right, title and interest in and to all claims for past, present, or future damages for all infringements or other unauthorized use of the patents, with the right to sue for and collect the same for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives; all rights to license, assign, pledge, and/or otherwise exploit such Transferred Patent, and the Assignors hereby authorize Assignee to request, and hereby request the Commissioner of Patents to issue any Letters Patent granted upon the invention set forth in said application to the Assignee, its successors and assigns; and the Assignors hereby agree that the Assignee may apply for foreign Letters Patent for the Transferred Patent and the Assignors will execute all papers necessary in connection with the United States and foreign applications when called upon to do so by the Assignee.

The parties agree (i) to furnish upon request to each other such further information, (ii) to execute and deliver to each other such other documents, and (iii) to do such other acts and things, all as the other party may reasonably request for the purpose of carrying out the intent of this Agreement and the transactions contemplated by this Agreement and to register or maintain the rights assigned herein.

This Agreement shall be binding upon and inure to the benefit of and be enforceable by Assignee and Assignors and their respective successors and permitted assigns. This Agreement is not intended to, and shall not be construed to, confer upon any person, other than Assignors and Assignee, any rights or remedies hereunder.

This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument. Facsimiles, e-mail transmission of pdf signatures or other electronic copies of signatures shall be deemed to be originals.


