ASSIGNMENT OF PATENTS

WHEREAS, Nokia of America Corporation (“NOKIA”), a Delaware corporation, with offices located at 600 Mountain Avenue, Murray Hill, New Jersey 07974, is the owner of record of the Assigned Patents (as defined below).

WHEREAS, SOUND VIEW INNOVATIONS, LLC (“SOUND VIEW”), a Delaware limited liability company, having offices at 2001 Route 46, Waterview Plaza, Suite 310, Parsippany, New Jersey 07054, United States of America, is desirous of acquiring the entire interest in and to the Assigned Patents (as defined below);

WHEREAS, NOKIA and SOUND VIEW have entered into a PATENT TRANSFER AGREEMENT for the Assigned Patents effective April 1, 2019, (“PT Agreement”) wherein NOKIA has agreed to sell and SOUND VIEW has agreed to purchase the Assigned Patents;

WHEREAS, capitalized terms used but not defined herein shall have the meanings set forth in the PT Agreement;

WHEREAS, this assignment (“Assignment”) is made by NOKIA subject to and contingent upon SOUND VIEW concurrently providing to NOKIA a Grant-Back License under the Grant-Back Licensed Patents and upon SOUND VIEW and its Affiliates making certain covenants in accordance with the PT Agreement; and

“Assigned Patents” means: (i) United States patent # US7627871, issued on 01-Dec-2009, entitled “Instructing management support software of a first software component to set up a communication channel between the first software component and a second software component”; and (ii) United States patent # US7509630, issued on 24-Mar-2009, entitled “Software component initialization in an ordered sequence”.

NOW, THEREFORE, to all whom it may concern, be it known that for good and valuable consideration to NOKIA (“Assignor”) in hand paid, the receipt, adequacy, and sufficiency of which is hereby acknowledged, NOKIA has sold, assigned, transferred, and set over, and by these presents does sell, assign, transfer, and set over unto said SOUND VIEW (“Assignee”), subject to all Encumbrances (where, for clarity, such Encumbrances shall run with the Assigned Patents), its entire right, title, and interest in and to all of the Assigned Patents, said entire right, title, and interest in and to said Assigned Patents including all past, present, and future causes of action and claims for damages derived by reason of patent infringement thereof (to the extent such damages are not already paid, awarded or contractually owed to NOKIA, its Affiliates or any predecessor of NOKIA or NOKIA’s Affiliates), but in all cases excluding any license fees, royalties or other amounts due under agreements existing as of the Effective Date, for said SOUND VIEW’s own use and for the use of its assigns, successors, and legal representatives to the full end of the term of the Assigned Patents. For clarity, the foregoing assignment does not include (i) any trademarks, trade dress, trade names, or other indicia of origin; (ii) except for inventions of the Assigned Patents, any inventions or discoveries, whether patentable or not, and registrations, invention

disclosures, patents and applications therefore; (iii) any trade secrets, confidential information or know-how; (iv) any works of authorship, whether copyrightable or not; and (v) any other intellectual property or proprietary rights of NOKIA, its Affiliates or any predecessor of NOKIA or NOKIA's Affiliates.

NOKIA, for itself, and its heirs, assigns, and legal representatives hereby further covenants to and with SOUND VIEW, its assigns, successors, and legal representatives to fully cooperate therewith in perfecting this assignment in the United States and in any and all foreign jurisdictions, said cooperation extending to the Assigned Patents, and including the execution of additional assignments or other formal documents as may be required in connection therewith, but in all such cases shall be at the expense of SOUND VIEW.
