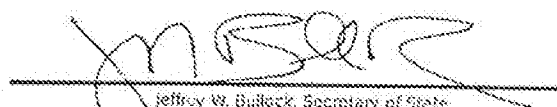

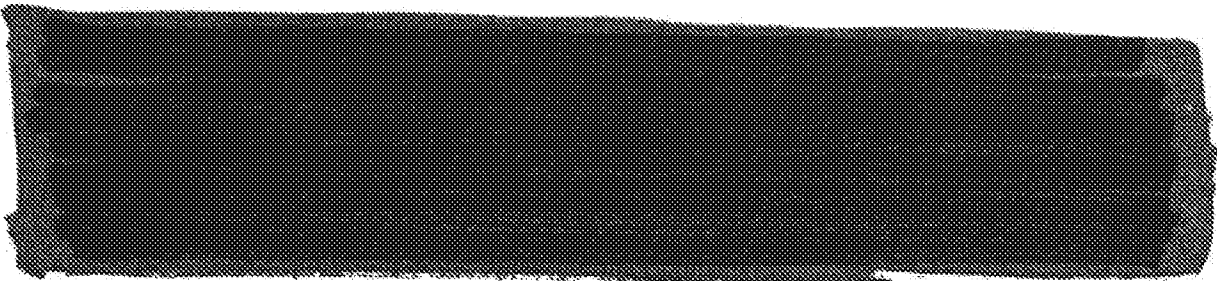
TWO: He is the duly elected and acting Chief Executive Officer of DCS Surgical, Inc., a Delaware corporation.

The name of this company is Sinopsys Surgical, Inc. (the "Company" or the "Corporation").





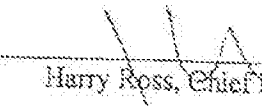
