The right to pursue, collect, and retain in the ASSIGNEE's name or otherwise, damages and any other remedies arising from any past, present, or future infringement of the Applications and Granted Rights and any other rights assigned by this Assignment.

ASSIGNOR authorizes ASSIGNEE to apply for and pursue protection for any part of or all of the Invention, the Applications and Granted Rights, and any other rights assigned by this Assignment in all countries, regions, and territories of the world, in the inventor(s)' or ASSIGNEE'S name.

ASSIGNOR hereby authorizes and requests the Commissioner of Patents to issue a Letters Patent to ASSIGNEE, for its interest as ASSIGNEE, its successors, assigns and legal representatives and hereby authorize(s) Melcher Patent Law PLLC to correct and/or insert hereon any further identification necessary or desirable for recordation of this document.

ASSIGNOR agrees upon request of said ASSIGNEE, and without further remuneration, to communicate to the ASSIGNEE or their representatives any facts known to the ASSIGNOR respecting the Invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, substitute, renewal, reexamination and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths and declarations, and generally do everything possible to aid said ASSIGNEE, their successors and assigns, to obtain and enforce proper protection for said invention in every country or region throughout the world.
