RELEASE OF PATENT SECURITY INTEREST

This RELEASE OF PATENT SECURITY INTEREST ("**Release**") is made and effective as of June 1, 2018 and granted by McHenry LLC (the "**Administrative Agent**"), a Delaware limited liability company, in its capacity as the Administrative Agent for the secured parties under the Loan Agreement referred to below (the "**Secured Parties**"), in favor of GridPoint, Inc., a Delaware corporation, and its subsidiaries, ADMMicro Properties, LLC, a Virginia limited liability company, and V2Green, Inc. a Delaware corporation (collectively, the "**Grantors**"), and their respective successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Senior Secured Loan Agreement, dated as of January 28, 2014, by and among GridPoint, Inc., as borrower, the Administrative Agent, and each of the lenders party thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Loan Agreement**"), the Grantors executed and delivered to the Administrative Agent (i) that certain Pledge and Security Agreement by and among the Grantors and the Administrative Agent dated as of January 28, 2014 (the "**Master Security Agreement**"), (ii) that first Confirmatory Security Agreement – Patents entered into by and among the Grantors and the Administrative Agent, dated as of January 28, 2014 (the "**First Patent Security Agreement**"), and (iii) that second Confirmatory Security Agreement - Patents entered into by and among the Grantors and the Administrative Agent, dated as of January 28, 2014 (the "**Second Patent Security Agreement**"), together with the First Patent Security Agreement and the Master Security Agreement, the "**Security Agreements**";

WHEREAS, pursuant to the Security Agreements, each Grantor pledged and granted to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor in, to and under the patents and patent applications listed on the attached Schedule A, and all proceeds thereof, including, without limitation, any and all causes of action which may exists by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "**Patent Collateral**");

WHEREAS, the First Patent Security Agreement was recorded with the United States Patent and Trademark Office on January 28, 2014, at Reel 032133, Frame 0617, with respect to that portion of the Patent Collateral owned by GridPoint, Inc., at Reel 032133, Frame 0656, with respect to that portion of the Patent Collateral owned by ADMMicro Properties, LLC, and at Reel 032140, Frame 0624, with respect to that portion of the Patent Collateral owned by V2Green, Inc.;

WHEREAS, the Second Patent Security Agreement was recorded with the United States Patent and Trademark Office on May 20, 2015, at Reel 035747, Frame 0556, with respect to that portion of the Patent Collateral owned by GridPoint, Inc.; at Reel 035749, Frame 0708, with respect to that portion of Patent Collateral owned by ADMMicro Properties, LLC, and at Reel 035747, Frame 0862, with respect to that portion of the Patent Collateral owned by V2Green, Inc.; and

WHEREAS, the Grantors desire that the Administrative Agent enter into this Release in order to effectuate, evidence and record the release of any and all right, title and interest the

Administrative Agent and the Secured Parties may have in the Patent Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby agrees as follows:

1. Release of Security Interest. Administrative Agent, on behalf of itself and the Secured Parties, and their respective successors, legal representatives and assigns, hereby terminates, releases, discharges, and reassigns to Grantors any and all security interests or other right, title, or interest of the Secured Parties pursuant to the Security Agreements in, to, and under the Patent Collateral.

2. Further Assurances. Administrative Agent agrees, at the Grantors' expense, to take all further actions, and provide to the Grantors and their respective successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.


