## ASSIGNMENT

WHEREAS, Kenneth J. Onion, of Kaneohe, Hawaii, has invented a certain invention, as described in the following patent applications:

U.S. Provisional Patent Application No. 61/772,449, filed on March 4, 2013, entitled

U.S. Patent Application No. 14/197,120, filed on March 4, 2014, entitled “EASILY

Chinese Patent Application No. 201410076626.0, filed on March 4, 2014, entitled

“EASILY DISASSAEMBLEMED FOLDING KNIFE,”

which applications are collectively referred to as “the patent applications.”

WHEREAS, GB II Corporation, an Oregon corporation doing business as Columbia River Knife and Tool (“CRKT”), having a place of business at 18348 SW 126th Place, Tualatin, OR 97062, has entered into a License Agreement with Ken Onion Hawaii, L.L.C., effective December 1, 2009; and

WHEREAS, CRKT is desirous of acquiring an interest in the invention and the patent applications:

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Kenneth J. Onion and Ken Onion Hawaii, L.L.C. (collectively, “Assignors”) hereby sell, assign and transfer to CRKT, the full and exclusive right, title and interest in and to said invention, said patent applications, and all patent rights pertaining to said invention and patent applications throughout the world, including foreign priority rights; said invention, patent applications and patents in the United States or any foreign country, and all corresponding non-provisional applications, divisions, continuations, continuations-in-part, reissues and extensions thereof, to be held and enjoyed by CRKT, for its own use and benefit, and for its successors and assigns to the full end of the term for which patents may be granted by the United States or any

foreign country, as fully and entirely as the same would have been held by Assignors had this assignment and sale not been made, and Assignors covenant that, to the best of Assignors' knowledge, Assignors have full right to do so, and that Assignors will communicate to CRKT, or its successors and assigns, any facts known to Assignors respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and make a good faith effort to aid CRKT, its successors and assigns to obtain and enforce proper patent protection for said invention in the United States or any foreign country. Assignors reserve the right to obtain and review any and all documents related to the patent applications, and will provide CRKT written notice and reasonable time to comply with such request.

Notwithstanding this Assignment, CRKT hereby grants Ken Onion Hawaii, L.L.C. a perpetual, royalty-free license to make products incorporating the invention for private party sales. This license may only be assigned or sublicensed to an entity that is at least 51% owned by Ken Onion, his wife, children, heirs and/or successors and only after providing written notification to CRKT of such assignment or sublicense. In all other instances, this license may not be assigned or sublicensed without prior written consent of CRKT, which may be unreasonably withheld.


This assignment does not affect CRKT's obligation to pay Ken Onion Hawaii, L.L.C. royalties in accordance with the License Agreement.

CRKT will, upon written request and receipt of payment from Ken Onion Hawaii, L.L.C., assign the patent applications and all corresponding patent rights to Ken Onion Hawaii, L.L.C. if one or both of the following conditions are satisfied: (1) CRKT has not made commercially reasonable efforts to manufacture and market products embodying the invention within three years of the filing date of the non-provisional patent applications or (2) CRKT has discontinued all products covered by the patent applications and has not manufactured any new products

covered by the patent applications within one year of the date that the last product covered by the patent applications was discontinued. Payment from Ken Onion Hawaii, L.L.C. to CRKT for the assignment of the patent applications and all patent rights under this paragraph shall be the total of all patent prosecution and patent maintenance costs, including government fees (including but not limited to filing fees and maintenance fees) and attorney fees, incurred by CRKT in relation to prosecuting and maintaining the patent applications and all patent applications and patents claiming priority to the patent applications or claiming subject matter disclosed in the patent applications.

Assignors hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment any further information which may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.


