- 1.2 any and all the rights of ownership concerning any patents or other forms of protection granted from The Application and the full and exclusive benefit of them, and all rights, privileges and advantages associated with them, including ;
- 1.3 the right to claim priority from The Application including under the Paris Convention (as amended) or equivalent Conventions or agreements when making further applications;
- 1.4 the right to maintain any patents and patent applications to which this Agreement relates in force and to exploit them directly or indirectly as the sole owner thereof;
- 1.5 the right to undertake, resume or continue, in its own name and at its own expense, risks and profits, as plaintiff or defendant, all rights, proceedings or actions concerning the rights assigned by this Agreement, including the right to legally pursue any usurpation or infringement, either before or after the date of this Assignment; and
- 1.6 the right to claim or obtain for its own exclusive benefit all damages or other remedies for any of the rights assigned by this Agreement, either before or after the date of this Assignment;


TO HOLD unto The Assignee absolutely.
