RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARK AND PATENT COLLATERAL

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARK AND PATENT COLLATERAL (this "Release") is made as of December 14, 2018, by Goldman Sachs Lending Partners LLC, in its capacity as collateral agent (in such capacity, the "Collateral Agent"), in favor of Refractory Specialties, Incorporated, an Ohio corporation ("Refractory"), Specialty Ceramics, Inc., an Ohio Corporation ("Specialty Ceramics"), Unifrax I LLC, a Delaware limited liability company ("Unifrax") and Vacuform, Inc., an Ohio corporation ("Vacuform and, together with Refractory, Specialty Ceramics and Unifrax, the "Grantors") pursuant to that certain Second Lien Credit Agreement, dated as of November 7, 2017 (as amended, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Credit Agreement") by and among Unifrax (the "Borrower"), UFX Holding II Corporation, a Delaware corporation ("UFX Holdings II"), Unifrax Holding Co., a Delaware corporation ("Unifrax Holdco" and, together with UFX Holdings II, the "Parent Guarantors") and certain Subsidiaries, as Subsidiary Guarantors, the Lenders party thereto from time to time, and Goldman Sachs Lending Partners LLC, as administrative agent for the Lenders and collateral agent and security trustee for the Secured Parties. Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Second Lien IP Security Agreements (as defined below) or, if not defined therein, the Second Lien Security Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS, Refractory is a party to that certain Second Lien Security Agreement, dated as of November 7, 2017 among Unifrax, the other Grantors party thereto and Goldman Sachs Lending Partners LLC, as Collateral Agent for the Secured Parties referred to therein, in favor of the Collateral Agent (as amended, amended and restated, supplemented, waived or otherwise modified from time to time, the "Second Lien Security Agreement"), pursuant to which Refractory executed and delivered that certain Trademark Security Agreement, dated as of November 7, 2017 (the "Refractory Trademark Security Agreement") and that certain Patent Security Agreement, dated as of November 7, 2017 (the "Refractory Patent Security Agreement" and, together with the Refractory Trademark Security Agreement, the "Refractory IP Security Agreements");

WHEREAS, Specialty Ceramics is a party to the Second Lien Security Agreement, pursuant to which Specialty Ceramics executed and delivered that certain Trademark Security Agreement, dated as of November 7, 2017 (the "Specialty Ceramics Trademark Security Agreement");

WHEREAS, Unifrax is a party to the Second Lien Security Agreement, pursuant to which Unifrax executed and delivered that certain Trademark Security Agreement, dated as of November 7, 2017 (the "<u>Unifrax Trademark Security Agreement</u>"), that certain Patent Security Agreement, dated as of November 7, 2017 (the "<u>Unifrax Patent Security Agreement</u>") and that certain Supplemental Patent Security Agreement, dated as of November 7, 2017 (the "<u>Unifrax Supplemental Patent Security Agreement</u>" and, together with the Unifrax Trademark Security Agreement and the Unifrax Supplemental Patent Security Agreement, the "<u>Unifrax IP Security Agreements</u>");

WHEREAS, Vacuform is a party to the Second Lien Security Agreement, pursuant to which Vacuform executed and delivered that certain Trademark Security Agreement, dated as of November 7, 2017 (the "Vacuform Trademark Security Agreement" and, together with the Refractory IP Security Agreements, the Specialty Ceramics Trademark Security Agreement and the Unifrax IP Security Agreement, the "Second Lien IP Security Agreements" and each, a "Second Lien IP Security Agreement");

WHEREAS, pursuant to the Second Lien IP Security Agreements, the Grantors pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of their right, title and interest in, to and under all of the following Collateral of the Grantor: (a) Patents of each Grantor listed on Schedule A attached hereto; (b) Trademarks of each Grantor listed on Schedule B attached hereto; (c) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, and all rights corresponding thereto throughout the world; (d) all claims and rights to recover for past, present and future infringement or dilution of or injury with respect to any of the foregoing; and (e) any and all Proceeds (as defined in the Second Lien Security Agreement) of or arising from any of the foregoing (collectively, the "Collateral");

WHEREAS, the Refractory Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 6199, Frame 0071 on November 7, 2017;

WHEREAS, the Refractory Patent Security Agreement was recorded with the United States Patent and Trademark Office at Reel 044057, Frame 0257 on November 7, 2017;

WHEREAS, the Specialty Ceramics Security Agreement was recorded with the United States Patent and Trademark Office at Reel 6199, Frame 0078 on November 7, 2017;

WHEREAS, the Unifrax Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 6214, Frame 0290 on November 7, 2017;

WHEREAS, the Unifrax Patent Security Agreement was recorded with the United States Patent and Trademark Office at Reel 044393, Frame 0273 on November 7, 2017;

WHEREAS, the Unifrax Supplemental Patent Security Agreement was recorded with the United States Patent and Trademark Office at Reel 044392, Frame 0366 on November 7, 2017;

WHEREAS, the Vacuform Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 6214, Frame 0299 on November 7, 2017;

WHEREAS, the Collateral Agent acknowledges full performance of the Secured Obligations and accordingly has agreed to release the grant of its lien on and security interest in and to all of the right, title, and interest of each Grantor in the Collateral, and to reconvey any and all rights in the Collateral to each such Grantor.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases, relinquishes and discharges, with respect to each Grantor, all of its lien on and security interest in and to all of each Grantor's right, title, and interest in, to and under the Collateral, and re-assigns to each such Grantor any and all right, title or interest it may have in such Collateral.

The Collateral Agent hereby authorizes each Grantor, or each such Grantor's authorized representatives to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or Agency and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Collateral Agent's lien on and security interest in the Collateral. The Collateral Agent agrees to execute and deliver to each such Grantor all other instruments and other documents as may be necessary or proper to release the lien on and security interest in the Collateral which had been granted under each Second Lien IP Security Agreement.

THIS RELEASE OF SECURITY INTEREST IN COLLATERAL AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER (INCLUDING, WITHOUT LIMITATION, ANY CLAIMS SOUNDING IN CONTRACT LAW OR TORT LAW ARISING OUT OF THE SUBJECT MATTER HEREOF AND ANY DETERMINATION WITH RESPECT TO POSTJUDGMENT INTEREST) SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK (OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST).
