And I hereby authorize and request any patent that issues to be issued to PostProcess Technologies, Inc. as the assignee of the whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for applications for patents, for filing subdivisions of said applications for patents, and for obtaining any reissue or reissues of any patent which may be granted for the aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
