AND WHEREAS, (1) TERA AUTOTECH CORPORATION, a corporation in Taiwan, having its principal place at NO.1 INDUSTRIAL PARK 7 RD., DAJIA DIST., TAICHUNG CITY, and (2) Department of Electrical Engineering, National Changhua University of Education, a department of an university in Taiwan at 1 Jin De Road, Changhua City, Taiwan (hereinafter referred to collectively as "ASSIGNEES") wish to acquire entire right, title and interest in and to these PATENT APPLICATION and said improvements, as well as the right of action and all other rights, including the right to sue or otherwise bring action and to collect and receive damages therefrom, for past infringement thereof, and to collect reasonable royalties based on the provisional rights thereof;


