

FURTHER, I agree that I will communicate to said **FELL Technology AS**, or its representatives, any facts known to me respecting said invention; testify in any legal proceedings; sign all lawful papers; execute all divisional, continuation, substitution, renewal, and reissue applications; execute all necessary assignment papers to cause any and all of said Letters Patent and the like to be issued to said **FELL Technology AS**; make all rightful oaths; and generally do everything possible to aid the said **FELL Technology AS**, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
