ASSIGNMENT OF IP RIGHTS

THIS DEED is made on 12 FEBRUARY 2015

BETWEEN

1. **Oceanlinx Limited** (in liquidation)(receivers and managers appointed) ACN 077 104 404 of c/- Deloitte Touche Tohmatsu, Grosvenor Place, Level 2, 225 George Street, New South Wales 2000, Australia (formerly of Suite 1 02 Tower A, Level 1, 112-118 Talavera Road, Macquarie Park, New South Wales 2113, Australia) (the **Assignor**)
2. **Wave Power Renewables Limited** (Company number 2063597) of Unit 5, 27/F, Richmond Commercial Building, 109 Argyle Street, Mongkok, Kowloon, Hong Kong (the **Assignee**)

BACKGROUND

- A. The Assignor is the owner of the patent applications listed in item 1 of the Schedule to this Deed (the **Patents**) and the trade mark listed in item 2 of the Schedule to this Deed (the **Trade Mark**).
- B. The Assignor has assigned to the Assignee all the Assignor's right, title and interest in and to the Patents and the Trade Mark with effect on and from 25 November 2014 (the **Effective Date**).
- C. Vaughan Neil Strawbridge and Jason Mark Tracey (the **Liquidators**) are signing this Deed solely in their capacity as joint and several liquidators of the Assignor to give effect to the transaction that the Liquidators entered into on behalf of the Assignor on the Effective Date in their capacity as voluntary administrators of the Assignor.

OPERATIVE PROVISIONS

1. The Assignor hereby confirms the assignment to the Assignee of, and the Assignee accepts absolutely, on and from the Effective Date:
 - (a) the entire right, title and interest in and to the Patents without geographical limit including the benefit of all priority rights and the right to file further applications based on the Patents such as but not limited to divisional, continuation and continuation-in-part applications, national phase applications, patents of addition and utility applications;
 - (b) all rights to register and otherwise exploit the Patents including all corresponding rights obtainable in respect of the inventions that are described and/or claimed in the Patents; and
 - (c) all rights, powers, liberties and immunities arising from any rights granted in relation to the Patents including the right to sue for and obtain injunctive relief, damages and all other remedies in respect of any infringement of the assigned rights which may have occurred prior to or after the date of the assignment or this Deed.
2. The Assignor hereby confirms the assignment to the Assignee of, and the Assignee accepts absolutely, on and from the Effective Date:

- (a) the entire right, title and interest in and to the Trade Mark; and
 - (b) all rights, powers, liberties and immunities arising from any rights granted in relation to the Trade Mark including the right to sue for and obtain injunctive relief, damages and all other remedies in respect of any infringement of the assigned rights which may have occurred prior to or after the date of the assignment or this Deed.
- 3. The Assignor agrees to use reasonable endeavours to effect the transfer or assignment of the right, title and interest of the Assignee to the Patents and Trade Mark.
- 4. The Assignee agrees and acknowledges that:
 - (a) All references to the Liquidators in this Deed are references to the Liquidators in their capacity as liquidators of the Assignor.
 - (b) that:
 - (i) the Assignee is contracting with Assignor for the purpose of dealing with the Patents and the Trade Marks under this Deed and not the Liquidators;
 - (ii) by entering into this Deed, the Liquidators are acting not in a personal capacity but as Liquidators of the Assignor.
- 5. For the avoidance of doubt, the Assignee agrees that in connection with the negotiation, execution and completion of this Deed, to the maximum extent permitted by law:
 - (a) the Liquidators are not personally liable under:
 - (i) this Deed;
 - (ii) the transactions contemplated by this Deed;
 - (iii) any act, matter or thing arising out of or in connection with this Deed; or
 - (iv) under any other deed, instrument or document entered into, under or in connection with this Deed;
 - (b) any loss, claim, damage or penalty the Assignee may have resulting from a breach of an implied or express term of this Deed or in connection with the Patents or Trade Marks, or both, must be made solely against the Assignor;
 - (c) the Assignee releases the Liquidators from liability to the Assignee for any loss, claim, damage or penalty on any ground in connection with this Deed, the Patents and/or the Trade Marks under any other deed, instrument or document entered into, under or in connection with this Deed; and
 - (d) each Liquidator is entitled to enforce his or her rights under this Deed independently of each other Liquidator.
- 6. The parties agree and acknowledge that:
 - (a) on 21 March 2014, the Assignor was placed into voluntary administration pursuant to section 436A of the Corporations Act 2001 (Cth);

- (b) on 26 March 2014, the Liquidators replaced the previously appointed voluntary administrators appointed to the Assignor and the Liquidators were appointed jointly and severally as administrators of the Assignor;
 - (c) on 25 November 2014, the Assignor and the Assignee entered into an Asset Sale Deed dated 25 November 2014 (**the Asset Sale Deed**);
 - (d) the Liquidators executed the Asset Sale Deed on behalf of the Assignor in their capacity as administrators of the Assignor as they were at the time;
 - (e) on 17 December 2014, the Assignor was placed into liquidation and the Liquidators appointed as liquidators of the Assignor;
 - (f) any reference to the Liquidators in this Deed also includes the Liquidators in their capacity as administrators of the Assignor at the relevant times.
7. This Deed is governed by and must be construed in accordance with the laws of New South Wales, Australia.






