3. Request the Director of the United States Patent and Trademark Office and foreign patent authorities to issue the patent or intellectual property rights, including foreign patents, to the Assignee;
4. Covenant with the Assignee that no assignment, grant, mortgage, license, or other agreement affecting the rights and property herein conveyed has been made to others by me and that full right to convey the same as herein expressed is possessed by me; and
