ASSIGNMENT

All rights of action on account of past, present and future misappropriation or unauthorized use of said Inventions and Designs in any form, including but not limited to any infringement of any patent that may issue from the Application or from any other patent applications directed to said Inventions and Designs, any other patents or similar grants or protection on said Inventions and Designs, and any trade secret misappropriation of said Inventions and Designs;
4. The right to Assignee to file in its name applications for patents and similar grants or protection for said Inventions and Designs in the United States and in any country or countries foreign to the United States; and

5. All international rights or priority associated with said Inventions and Designs, said Application, and any other applications for patents, patents and similar grants or protection on said Inventions and Designs.

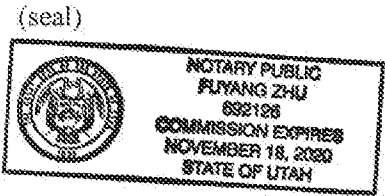

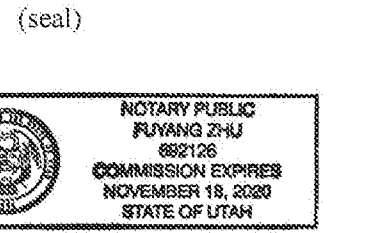

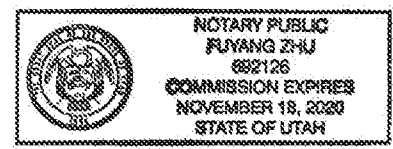
