- (c) the application for United States Letters Patent Serial No. 16/001,408 filed on June 6, 2018, which claims priority from provisional application Nos. 62/516,422 and 62/541,996 and 62/577,963 (I hereby authorize insertion of the serial number and filing date upon filing of this application);
- (d) any Letters Patent issued pursuant to, or as a result of, any application referenced above;
- (e) all applications for Letters Patent, or similar legal protection, which may be filed in any country or countries foreign to the United States with respect to the Invention.
- (f) all Letters Patent which may be granted for the Invention in any country or countries foreign to the United States; and
- (g) all extensions, renewals, reissues, divisions, continuations and continuations-in-part (or their legal equivalents) of any applications or Letters Patent referred to above.

2. I authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents or similar legal protection on applications, to issue to Assignee all Letters Patent or similar legal protection for the Invention or improvements.

3. I agree that, upon the request of Assignee, I will

- (f) perform such additional acts as Assignee may deem necessary or expedient in connection with any of the matters stated above.

4. I covenant and warrant that as of the effective date of this Assignment Agreement, I am (or as the case may be glori, llc already is by virtue of a previously Assignment instrument) the true and lawful owner of the entire right, title, and interest in the Invention, application for Letters Patent, and any Letters Patent which may issue under said application, and have the full right and power to convey the same; that the same are free and clear of all liens, charges and encumbrances whatsoever; and that I have not executed and will not execute any agreement in conflict with this Assignment Agreement.
