## SUPPLY AGREEMENT

This Supply Agreement (the "Agreement") is between The Lincoln Electric Company, an Ohio corporation headquartered at 22801 Saint Clair Avenue in Cleveland, Ohio (said company is hereinafter referred to as "Lincoln") and Tecmen Electronics Co Ltd, a whose address is No. 21 North Liuzhou Road, Xiaoliu Industrial Park, Nanjing Jiangsu 210031, China (said company is hereinafter referred to as "Supplier") with respect to the following Recitals.

### RECITALS:

**WHEREAS**, Supplier is engaged in the business of manufacturing and selling welding helmets and related replacement parts (hereinafter such products are referred to as the "Products"); and


**WHEREAS**, Lincoln requires the Products in connection with the operation of its business and the production of the products that it manufactures; and







**NOW THEREFORE**, in consideration of the mutual covenants, promises, agreements, and undertakings hereinafter set forth, the parties hereto agree as follows:



**DECLARATION of JAMY BULAN**

I, Jamy Bulan, hereby declare as follows:

1. The following statements are within my personal knowledge and are true and correct.
2. I am currently employed by The Lincoln Electric Company as Business Manager Environmental Products.
3. I am a co-inventor on the following U.S. design patent applications:
  - U.S. Design Patent Application No. 29/639,562, entitled "Top of Helmet Shell" filed on March 7, 2018;
  - U.S. Design Patent Application No. 29/639,579, entitled "Inner Shell for Helmet" filed on March 7, 2018;
  - U.S. Design Patent Application No. 29/639,566, entitled "Top Shell for Helmet" filed on March 7, 2018;
  - U.S. Design Patent Application No. 29/641,668 , entitled "Shield Holder Frame" filed on March 23, 2018;
  - U.S. Design Patent Application No. 29/639,572, entitled "Cover Lens Frame" filed on March 7, 2018; and
  - U.S. Design Patent Application No. 29/639,586, entitled "Headgear of Helmet" filed on March 7, 2018.
4. The inventors listed on each of these design patent applications are Mircea Rosca, Jamy Bulan, and Ziqian Wu.

5. It is my understanding that co-inventor Ziqian Wu was an employee of Tecmen Electronics Co. Ltd., at the time of the invention of these design patent applications. It is also my understanding that Ziqian Wu co-developed the inventions of these design patent applications in the course of performing his job responsibilities for Tecmen Electronics Co. Ltd.
6. I understand that The Lincoln Electric Company and Tecmen Electronics Co. Ltd. signed a Supply Agreement in 2012. Under that agreement, I understand that Tecmen Electronics Co. Ltd. has an obligation to assign to The Lincoln Electric Company "any new design, intellectual property, technology or related product improvements that result from any ... joint development efforts" between The Lincoln Electric Company and Tecmen Electronics Co. Ltd. A redacted copy of the Supply Agreement is included with this Declaration as Exhibit A.
7. It is my understanding that each of the design patent applications listed above was the result of joint development efforts between The Lincoln Electric Company and Tecmen Electronics Co. Ltd. with respect to the design of welding helmets, consistent with the terms of the Supply Agreement.
8. I understand that on August 17, 2018, co-inventor Ziqian Wu from Tecmen Electronics Co. Ltd. signed declarations supporting the filing of these design patent applications in the United States.
9. I also understand that on August 17, 2018, co-inventor Ziqian Wu from Tecmen Electronics Co. Ltd. was asked to sign an assignment of these design patent applications to The Lincoln Electric Company, consistent with the terms of the Supply Agreement, but he refused to do so.
