which is set forth in United States patent Application Serial No. 62/054,542, filed September 24, 2014.

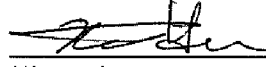

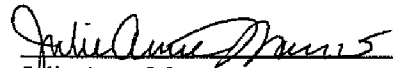

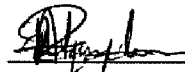
