the same to be held and enjoyed by the Assignee, its successors, assigns, nominees or legal representatives, to the full end of the term or terms for which such patents respectively may be granted, reissued or extended, as fully and entirely as the same would have been held and enjoyed by the Assignor, had this Assignment, sale and transfer not been made.

The Assignor hereby covenants that it: has full right to convey the entire interest herein assigned; has not encumbered the rights and properties transferred by this Assignment in any manner; and has not executed and will not execute any agreement to transfer any rights in the Inventions and/or the Application to anyone other than the Assignee; or that is otherwise in conflict herewith.
