3. REPRESENTATIONS AND WARRANTIES


3.1 Each assignor individually represents and warrants that he not encumbered the Assigned Patent, and that he has granted no third party any license or other interest in the Assigned Patent.


4. MISCELLANEOUS



4.3 This Assignment is binding upon, inures to the benefit of, and is enforceable by the parties hereto and their respective successors.


