WHEREAS, We, Ioannis Katsavounidis, a Greek citizen, residing at 222 S. El Molino Ave., Apt. 7, Pasadena, California 91101; Chang-Su Kim, a South Korean citizen, residing at WonHyo 1-4, YongSan-Ku, Seoul 151-742, South Korea; and JongWon Kim, a South Korean citizen, residing at Dongbu Apt 104-601, Wolgye-Dong, Gwangsan-Gu, GwangJu 506-769, South Korea, have invented certain new and useful improvements in a **SYSTEMS AND METHODS FOR DECODING OF PARTIALLY CORRUPTED REVERSIBLE VARIABLE LENGTH CODE (RVLC) INTRA-CODED MACROBLOCKS AND PARTIAL BLOCK DECODING OF CORRUPTED MACROBLOCKS IN A VIDEO DECODER** for which we have filed an application for Letters Patent in the United States with Application No. 10/092,376, filed on March 5, 2002;

AND WE HEREBY covenant and agree that we will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

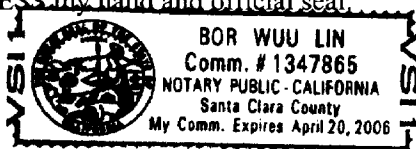
