3. The Assignee desires to acquire the entire right, title and interest in and to the Invention.
4. The Assignor has agreed to assign its share of the Invention to the Assignee upon the terms and conditions set out hereunder.

NOW THIS ASSIGNMENT WITNESSETH AS FOLLOWS:

1. In consideration of the sum of **S\$1.00** now paid by the Assignee to the Assignor (the receipt and sufficiency of which is hereby acknowledged), the Assignor hereby assigns absolutely to the Assignee free from encumbrances:
 - 1.1 ALL of its right, title and interest in and to the Invention and, as of the effective date hereinafter defined, all rights and powers arising or accrued therefrom including the right to apply for, prosecute and obtain patent or similar protection throughout the world in respect of the Invention including the right to claim priority therefrom to the intent that the grant of any patent(s) or similar protection shall be in the name of and vest in the Assignee; and
 - 1.2 The right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of

the patent or similar protection, any published specification of the patent or similar protection, or accompanying any application therefor irrespective of whether such infringement or acts took place before or after the date of this Assignment;

TO HOLD the same unto the Assignee and its successors and assigns absolutely.

2. This Assignment is to have an effective date of 7 May 2019.
3. The Assignor further covenants that at the request and cost of the Assignee, the Assignor will execute all such documents and do all such acts as may reasonably be necessary or proper to secure the vesting in the Assignee of all rights assigned hereunder.
4. This Assignment shall be governed by and construed in accordance with the laws of Singapore, without regard to its conflict of laws principles. The parties hereby irrevocably consent to the exclusive jurisdiction of and venue in the courts of Singapore.
5. This Assignment may be executed in two (2) or more counterparts, each of which will be considered an original, but all of which together will constitute one and the same instrument. The exchange of a fully executed Assignment (in counterparts or otherwise) by fax or electronic transmission is sufficient to bind the parties to the terms and conditions of this Assignment.
