GRANT OF FIRST LIEN SECURITY INTEREST IN UNITED STATES PATENTS

THIS GRANT is made to secure the satisfactory performance and payment of all the Secured Obligations of each applicable Grantor, as such term is defined in the First Lien Security Agreement by, among Grantee, WHEEL PROS INTERMEDIATE, INC., a Delaware corporation, as a Guarantor, and the other Grantors (as such term is defined therein) party thereto, dated as of April 4, 2018 (as amended by the Joinder Agreement to the First Lien Security Agreement, dated as of the date hereof, by and between each Grantor and Grantee, and as further amended, modified, restated and/or supplemented from time to time, the “Security Agreement”). The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


