BY AND BETWEEN

Assignor hereby also sells, assigns and transfers unto Assignee, the entire right, title and interest in and to the invention and in and to applications for Letters Patent therefore in all countries foreign to the United States of America, including all rights under any and all international conventions and treaties in respect of the invention and the applications for Letters Patent in foreign countries, and Assignor, further authorizes Assignee to apply for Letters Patent in foreign countries directly in its own name, and to claim priority of the filing date of the application for Letters Patent of the United States of America under the provisions of any and all international conventions and treaties.

Assignor hereby authorizes and requests the Commissioner of Patents of the United States of America to issue Letters Patent upon the aforesaid applications, divisions, extensions, continuations or reissues, to Connected Pattern Technology LLC for the sole use and benefit of Connected Pattern


