AND

WHEREAS

Claverham shall have the right to file applications for and/or be granted patents, utility models, registered designs, design patents, and any other intellectual property rights in its own name or in the names of the Inventors or in such other name or names as Claverham may desire and the Inventors acknowledge that if any such applications are filed or rights granted in the name of the Inventors the same shall be held in trust by the Inventors for Claverham and shall at the request of Claverham be transferred from the Inventors to Claverham for no further consideration.

registered designs, design patents or any other intellectual property rights in the inventor's own names in respect of the United States of America or any other country.


