The Assignor agrees that this general assignment is effective as the last date written below.





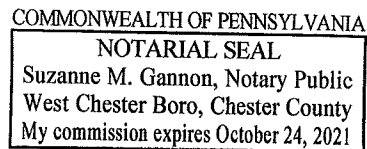
