RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS (this “Release”) is made as of May 16, 2019 (the “Effective Date”) by Lincolnshire Management, Inc. (the “Administrative Agent”), in favor of True Temper Sports, Inc. (“Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit and Security Agreement or the Patent Security Agreement (as defined below), as applicable.

WHEREAS, Grantor, the Administrative Agent, and the other parties thereto entered into that certain Credit and Security Agreement, dated as of May 27, 2016 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Credit and Security Agreement”), which required the parties to enter into the Patent Security Agreement (defined below);

WHEREAS, Grantor and the Administrative Agent entered into that certain Patent Security Agreement, dated May 27, 2016 (the “Patent Security Agreement”), under which Grantor mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Patent Collateral, including its Patents and applications therefor listed on Schedule 1 hereto; and such Patent Security Agreement was recorded with the United States Patent and Trademark Office on May 27, 2016, at Reel 038831, Frame 0987; and

WHEREAS, Grantor has satisfied the terms of the Patent Security Agreement and requests a specific release of the security interest granted and recorded against the Patent Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Patent Security Agreement, (ii) releases any and all liens, security interests, right, title and interest the Administrative Agent or any Secured Party may have in, to or under the Patent Collateral, (iii) re-assigns to Grantor, any right, title or interest the Administrative Agent or any Secured Party may have in, to or under the Patent Collateral and (iv) hereby authorizes the Grantor or the Grantor’s authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
