request to the ASSIGNEE, its successors and assigns any facts relating to said invention and the history thereof known to them or to their heirs and legal representatives, and that they will testify as to the same in any interference to obtain or any other litigation to enforce the patent or patents which may be granted for said invention when requested to do so by the ASSIGNEE, its successors and assigns. The ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks to issue said Design Letters Patent which may be granted for said invention to the ASSIGNEE as the assignee of the entire right, title and interest therein.
