ASSIGNMENT

- 2. Herein, the "Patent" means the Patent Application and all related: (i) inventions, ideas, discoveries, designs, drawings, illustrations, embodiments, improvements and related patent matters included, described or claimed therein; (ii) patent applications or patents (provisional or non-provisional) derived therefrom or relating thereto; and (iii) amendments, modifications, supplements, divisions, continuations, substitutions, renewals, extensions or reissues thereof.
- 3. This Assignment: (i) shall bind, and inure to the benefit of, the parties and their respective heirs, administrators, executors, successors and assigns; and (ii) shall not be amended except by a writing signed by the party against whom enforcement is sought. Each party shall from time to time reasonably cooperate to execute and deliver reasonable documents necessary to further evidence or effectuate this Assignment and all transactions contemplated hereunder. The word "including" or "include(s)" shall be construed and interpreted as also meaning "without limitation." Provisions hereof are severable, such that, if any shall be held unenforceable, the other remain enforceable. This Assignment and all transactions contemplated hereunder shall be governed, construed and interpreted in accordance with the laws of the State of New Jersey without regard to conflict of laws principles except as necessarily governed, construed and interpreted in accordance with United States federal patent laws, in which case, such patent laws shall apply.
