CONFIRMATORY ASSIGNMENT OF PATENTS AND TRADEMARKS

WHEREAS, public records presently indicate that Assignor is the sole owner of all right, title and interest in and to the pending trademark applications and registered trademarks identified in Appendix B attached hereto, and the goodwill of the business symbolized thereby ("Trademarks"); and

WHEREAS, although public records indicate ownership of the Patents and Trademarks by Assignor, at all relevant times both Assignor and Assignee have operated as if the Patents and Trademarks were owned by Assignee, including but not limited to Assignee paying all fees and expenses associated with developing and protecting the Patents and Trademarks; and

WHEREAS, for purposes of confirming Assignee's ownership of the Patents and Trademarks and publicly recording Assignee's ownership, Assignor desires to assign and transfer to Assignee all of its right, title and interest (if any) in and to the Patents and Trademarks, and Assignee desires to acquire the same; and

NOW, THEREFORE, in consideration of these premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and the Assignee agree as follows.

I. Assignment of Patents.

Assignor hereby sells, assigns and transfers to Assignee, its successors, assigns and legal representatives, all right, title and interest throughout the world in and to the Patents, existing improvements thereto, know-how, technology, concepts, methods, processes, formulae, data and other proprietary information therein, together with all rights to sue for past, present and future infringement of said Patents and all causes of action (either at law or equity) with respect thereto,

the right of recovery, including but not limited to damages, for such infringement, and the right to assign the rights conveyed herein, the same to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives. Assignor hereby authorizes Assignee to record ownership of the Patents directly in Assignee's own name in any jurisdiction, municipality or agency in which recordation is required.

II. Assignment of Trademarks.

Assignor hereby sells, assigns and transfers to Assignee, its successors, assigns and legal representatives, all right, title and interest throughout the world in and to the Trademarks, together with all goodwill of the business symbolized by the Trademarks, as well as all rights to sue for past, present and future infringement of said Trademarks and all causes of action (either at law or equity) with respect thereto, the right of recovery, including but not limited to damages, for such infringement, and the right to assign the rights conveyed herein, the same to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives. Assignor hereby authorizes Assignee to record ownership of the Trademarks directly in Assignee's own name in any jurisdiction, municipality or agency in which recordation is required.

III. Further Documentation.

Assignor agrees to execute and provide to Assignee promptly after execution and delivery of this Assignment of Patents and Trademarks such further instruments and documents and assignments as may reasonably requested by Assignee and reasonably necessary to effectuate the purpose of this Assignment of Patents and Trademarks and to enable Assignee to record in Assignee's name all of Assignor's rights in and to the Patents and Trademarks with the U.S. Patent and Trademark Office or any other appropriate governmental agency.

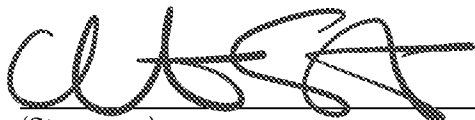
