This Assignment may be recorded with any governmental body in order to perfect the ownership interest of Assignee.

Assignor authorizes Assignee to file patent applications in any or all countries on the Transferred Patents in the name of the Assignee or otherwise as Assignee may deem advisable under the International Convention or otherwise.

Assignor agrees, without further consideration, to execute all oaths, assignments, powers of attorney, applications and other papers reasonably necessary to secure to Assignee the right, title and interest conveyed herein, and to take such further actions as may be reasonably requested by Assignee in order to carry out the provisions and purposes of this Assignment including, without limitation, to execute one or more further assignments covering the Transferred Patents in a form acceptable for recordation in both the United States Patent and Trademark Office and in foreign patent offices.

Assignor authorizes and requests the Commissioner of Patents and Trademarks and his or her non-US counterparts to issue any and all patents resulting from the Transferred Patents or derived therefrom to the Assignee as assignee of the entire interest therein.


