ASSIGNMENT OF PATENT RIGHTS

WHEREAS, Assignor is the sole owner of the "Protective Pad for Use During Athletic Activities" invention as described in U.S. Patent Number 8,383,229.



This Assignment and all matters relating hereto, including any matter or dispute arising out of the Assignment, shall be governed by and construed in accordance with the internal laws of the State of New Mexico without regard to its conflicts of laws principles. The parties agree and consent that any causes of action or suits related to this Assignment must be filed in the state or federal courts of State of New Mexico located in Albuquerque, New Mexico. The parties consent to the exclusive jurisdiction of said courts and waive any objections to such jurisdiction. The parties waive their right to request a change of venue.
5. If any term of this Assignment is to any extent invalid, illegal, or incapable of being enforced, such term shall be excluded only to the extent of such invalidity, illegality, or unenforceability and all other terms shall remain in full force and effect.


