DEED OF TRANSFER OF PATENTS

THE UNDERSIGNED:

1. Koninklijke Philips N.V., a public limited company incorporated in the Netherlands, with registered address at High Tech Campus 5, 5556 AE, Eindhoven, the Netherlands ("Royal Philips"),

and

2. Philips Lighting Holding B.V., a limited liability company incorporated under the laws of the Netherlands, with registered address at High Tech Campus 45, 5656 AE Eindhoven, the Netherlands ("Philips Lighting")

HAVE AGREED AS FOLLOWS:

1. Definitions

When used in this Deed, the following capitalized terms shall have the meaning set forth below:

"Affiliate" shall mean with respect to any Person, another Person directly or indirectly Controlling, being Controlled by, or being under common Control with the first Person on the date on which, or at any time during the period for which, the determination of affiliation is being made (i.e. whether now or in the future), provided that for purposes of this Agreement, at or after the Separation Date, (i) neither Philips Lighting nor any of its Subsidiaries shall be deemed to be an Affiliate of Royal Philips or of any of its Affiliates and (ii) neither Royal Philips nor any of its Affiliates, excluding Philips Lighting and its Subsidiaries, shall be deemed to be an Affiliate of Philips Lighting or any of its Subsidiaries;

"Annex" means the annex to this Deed.

"Control" of a Person shall mean, with respect to a Person, (i) the direct or indirect ownership of more than fifty per cent (50%) of the outstanding voting securities (or comparable voting interest or financial participation) of such Person, (ii) the ability to appoint more than half of the directors of the board of directors or equivalent governing body of such Person, or (iii) the possession, directly or indirectly, of the power to direct or cause the direction of the management or policies of such Person. The terms "Controlling", "Controlled by" and "under common Control" shall have the correlative meanings;

"Deed" means this deed of transfer of Patents including the Annex;

"Party" shall mean Royal Philips or Philips Lighting individually and "Parties" means Royal Philips and Philips Lighting collectively;

"Patents" shall mean any patents, petty patents, utility models and applications therefor, including any divisionals, amendments, substitutions, continuations, continuations-in-part, re-examinations, renewals, re-issues and extensions thereof, existing in any country in the world;

"Person" shall mean any individual, company or corporation, partnership, joint venture, joint stock corporation, limited liability company, trust, association, foundation or other legal entity or unincorporated organization, including a Governmental Authority;

"Pro Forma Assignment" shall mean a simple form of assignment containing solely the language required by the applicable law of an issuing jurisdiction to effectuate recordal of the assignment of the Patents as per this Deed; and

"Subsidiary" shall mean, with respect to Philips Lighting, another Person, directly or indirectly Controlled by Philips Lighting, whether now or in the future.

2. Transfer of ownership Patents;

Royal Philips has assigned and agreed to transfer, and has caused its relevant Affiliates to assign and transfer, and Royal Philips hereby assigns and will cause its relevant Affiliates to assign and transfer, to Philips Lighting all of Royal Philips' and, as applicable, its Affiliates' rights, title and interest in and to the Patents listed in the Annex, including all rights (a) in and to causes of action and enforcement rights for such Patents to pursue damages, injunctive relief and other remedies for past, present and future infringement of such Patents; and (b) all rights to apply in any and all countries in the world for Patents for any inventions disclosed in the Patents listed in the Annex. Philips Lighting has accepted, and hereby accepts, such assignment.

3. Amendments

No variation, extension, cancellation or translation of any expressed terms of this Deed shall be binding upon Royal Philips or Philips Lighting unless made in writing and signed by duly authorized representatives of Royal Philips and Philips Lighting.

4. Effectuation

Philips Lighting will be responsible for effectuating the recordal of the assignment and transfer of the Patents listed in the Annex. In the event that, in addition to this Deed, Philips Lighting needs to submit other documents to any patent authorities in order to effectuate the recordal of the assignment and transfer of the Patents listed in the Annex, Philips Lighting hereby warrants and guarantees that such other documents will not contain language that in any way prejudices the provisions of this Deed. The Parties shall, at each other's request, (and shall cause their relevant Affiliates to) execute and deliver such written instruments and otherwise do whatever may from time to time reasonably be necessary to fully effectuate the recordal of the assignment and transfer of the Patents listed in the Annex. The Parties may also agree in good faith, for purposes of recordal of the assignment of the Patents as per this Deed, to execute Pro Forma Assignments or adjust this Deed provided that Philips Lighting hereby warrants and guarantees that such other documents will not contain language that in any way prejudices the provisions of this Deed.

5. Observance legal requirements

Philips Lighting undertakes to observe, and act in accordance with, all applicable legal requirements relating to the effectuation of the recordal of the assignment and transfer of the Patents listed in the Annex.

6. Costs for recordal

Any costs related to the recordal of the assignment and transfer of the Patents listed in the Annex in the relevant registers will be borne by Royal Philips.

7. Applicable law and jurisdiction

This Deed and the documents to be entered into pursuant to it, save as expressly otherwise provided therein, shall be governed by and construed in accordance with the laws of the Netherlands, provided that to the extent that any provisions of the law of the issuing jurisdiction are mandatory for assignment of Patents, such specific provisions of that law shall prevail.



The Parties shall attempt in good faith to resolve promptly any dispute arising out of or relating to this Deed by negotiation between a duly authorized representative of each Party, including disputes concerning the existence, validity and termination of this Deed.

If the Parties are unable to resolve any such dispute as provided above, any such dispute arising out of or relating to this Deed shall be submitted to the competent courts of The Hague, the Netherlands, without prejudice to the right of either Party to seek injunctive relief in any place where an infringement of its rights occurs or threatens to occur.
