RECITALS

3. AUTHORITY

The Assignor authorises the Assignee to file and prosecute an application for patent or other protection for the Invention in the name of the Assignor if such an application is required by the laws of any country.

4. FURTHER ASSURANCE

The Assignor undertakes to do all acts and to execute and deliver all documents necessary for further assuring the right, title and interest of the Assignee in and to the Invention and any patent or similar protection for the Invention in Australia or elsewhere.

5. GOODS AND SERVICES TAX

- (a) The Assignee will pay to the Assignor all taxes or imposts in the nature of a goods and services tax ("GST") as may be assessed from time to time in connection with the Assignment, pursuant to relevant legislation.


- (b) The Assignor will, as may be required by the relevant legislation from time to time, issue a certificate ("Tax Invoice") to the Assignee in respect of the GST.
- (c) Within seven days of receipt of the Tax Invoice, the Assignee will pay to the Assignor the amount of the GST identified in the Tax Invoice.


